Completing the DSPT


- It is not just the IG Team's responsibility.
- Allocate assertions to individuals i.e. HR or IT.
- Have them report at IG Steering Group or submit a monthly report on progress.
- Have support from your SIRO to ensure reports are submitted.
- Plan to complete the DSPT by end of April at the latest. (shhh it gives time for any slippages!)
- Make sure IT has a plan for Cyber Essentials to be completed in time for submission.
- · Complete any actions from the Auditors.
